- **Research** browse all available scholarships to find out what's on offer
- **Check if you qualify** Read through the criteria to see if you are eligible.
- **3 Check application dates** Scholarship applications are now open.
- **Prepare your information** Think about what you want to include with your application and, if required, who you will use as your referee(s).
- **Complete your application** Ensure you submit your information before the closing date.
 - **Sit back and wait!** The selection process typically takes 6-8 weeks but may take longer. Don't worry we will notify you as soon as a decision has been made.
